

Amends Notification No. 9/2017- Integrated Tax (Rate) so as to exempt certain services as recommended by Goods and Services Tax Council in its 31st meeting held on 22.12.2018.

G.S.R (E).- In exercise of the powers conferred by sub-section (1) of section 6 of then Integrated Goods and Services Tax Act, 2017 (13 of 2017), the Central Government, on being satisfied that it is necessary in the public interest so to do, on the recommendations of the Council, hereby makes the following further amendments in the notification of the Government of India, in the Ministry of Finance (Department of Revenue) No.9/2017-Integrated Tax (Rate), dated the 28th June, 2017, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i) vide number G.S.R. 684 (E), dated the 28th June, 2017, namely:-

In the said notification, -

(i)in the Table, -

a. after serial number 22A and the entries relating thereto, the following serial number and entries shall be inserted, namely: -

c. against serial number 35A, in the entry in column (3), after the letters and words "PSUs from the", the words "banking companies and" shall be inserted;



- d. against serial number 69, for the entry in column (2), the following entry shall be substituted namely:
- "Heading 9992 or Heading 9963";
- e. serial number 70 and the entries relating thereto, shall be omitted;

f. after serial number 77 and the entries relating thereto, the following serial number and entries shall be inserted, namely: -

(ii) in paragraph 2, after clause (za), the following clause shall be inserted, namely: -

2. This notification shall come into force on the 1st day of January, 2019.
